

General Terms and Conditions for Ticket Sales (GTC-T) for the Bundeswehr Education and Training Congress and the Co- Conference "Designing Security as a Grand Challenge"

at the Helmut Schmidt University/University of the Federal Armed Forces Hamburg
(HSU/UniBw H)

1. Subject matter of the contract

The Bundeswehr Education and Training Congress and the co-conference "Designing Security as a Grand Challenge" (hereinafter referred to as the event) combines two events under one roof - with a scientific and practice-oriented conference and an accompanying trade exhibition. The Bundeswehr Education and Training Congress will be held as a hybrid event, meaning that participation is possible both - on site and virtually. **The kick-off conference "Designing Security as a Grand Challenge", on the other hand, is only designed as an in-person event.** The Center for Technology-Based Education (ZtB) of HSU/UniBw H is the organizer of the Bundeswehr Education Congress, while the Institute for Technology and Innovation Management of HSU together with the Archipelago of Design is the organizer of the conference "Designing Security as a Grand Challenge" (hereinafter referred to as the organizer).

The following General Terms and Conditions (GTC-T) apply to the ordering and purchase of admission tickets (congress ticket) for the Bundeswehr Education Congress and the conference "Designing Security as a Grand Challenge" at the Helmut Schmidt University/University of the Federal Armed Forces Hamburg (HSU/UniBw H), which the participant orders or purchases via online booking on the Internet or at the box office. ordered or purchased at the box office.

2. Exclusive validity of the GTC-T

The following GTC-T apply exclusively within the scope of these services.

3. Conclusion of the contract

3.1 All offers made by HSU/UniBw H are non-binding. The contract between the participant(s) and HSU/UniBw H is concluded by an order placed by the participant(s) and its acceptance by HSU/UniBw H. The order of the participant(s) is placed online by filling in the registration form provided by HSU/UniBw H on the Internet, by e-mail or by purchasing at the box office. HSU/UniBw H accepts the participant's order by confirming the registration at the end of the online ordering process.

3.2 Orders will be accepted until the end of August 27, 2025. After that date, admission tickets (congress tickets) can only be purchased at the box office.

4. Delivery

Unless otherwise agreed, the paid admission tickets (congress tickets) will be deposited at the information point in the entrance area of the main building of the university. The access data for virtual participation will be sent to participants by e-mail in good time before the start of the event.

5. Prices

The admission prices quoted are gross prices. The total costs will be calculated during the ordering process and displayed to the participant. The kick-off conference "Designing Security as a Grand Challenge" will take place over two days and is open to the public. The prices are based on those of the Bundeswehr Education and Training Congress and amount to **€320.00** if booked by July 20, 2025, **€360.00** by August 27, 2025, and **€380.00** at the box office from September 2, 2025.

Members of the program committee, federal and state civil servants (including former civil servants), members of other public bodies and institutions recognized as non-profit organizations are admitted free of charge upon presentation of proof. The same applies to students and pupils.

Discounts on the ticket price only become effective after sending a copy/scan of a valid ID or an equivalent certificate by email to designingsecurityconference@hsu-hh.de. If proof of eligibility in accordance with the above criteria cannot be provided, the full ticket price must be paid. Members of the German Armed Forces do not require separate proof. In this case, eligibility will be checked by the organizer.

6. Payment

Payment shall be made by invoice. The address given corresponds to the invoice address, unless a different address is explicitly stated. The invoice will be sent to you by e-mail.

7. Warranty and liability

7.1 The warranty is governed by the statutory provisions, unless otherwise stipulated below.

7.2 HSU/UniBw H shall only be liable for damage to property or financial losses that do not relate to the purchased service itself in the event of intentional or grossly negligent behavior.

7.3 In cases of (ordinary) simple negligence, HSU/UniBw H shall only be liable for property damage and financial losses that do not relate to the purchased service itself in the event of a breach of so-called cardinal obligations. In this respect, liability is limited to the foreseeable typical contractual damage. Liability for contractually typical, indirect contractual damages or consequential damages is excluded.

7.4 Insofar as the liability of HSU/UniBw H is limited, this also applies to the liability of all persons whose behavior can be attributed to HSU/UniBw H.

8. Right of withdrawal

The participant has the option of revoking his/her declaration of intent to conclude the order within two weeks of receipt of the confirmation of registration by sending a declaration in text form to/against HSU/UniBw H. The revocation does not have to include a reason. The revocation does not have to contain a reason. Timely dispatch (date of postmark/e-mail) is sufficient to meet the deadline.

9. Right of return

There is a right to return the ordered admission ticket(s) (conference tickets) under the following conditions:

For cancellations up to 14 days before the start of the event, the participation fees already paid will be refunded, reduced by a processing fee of EUR 50.00. HSU/UniBw H must be notified of the return in writing. Timely dispatch (date of postmark/e-mail) is sufficient to meet the deadline.

10. Networking event

The organizer offers the opportunity to participate in a networking event. Congress participants can purchase tickets for the evening event for a fee. Cancellation of booked tickets is possible up to 14 days before the networking event takes place. After the cancellation deadline, the participation fee is due in full.

11. Catering services

In the main university building, refreshments will be available for a fee in the cafeteria from 8:00 a.m. to 5:00 p.m. daily during the event. The catering services of the university canteen can be used by congress participants for a fee.

12. Data protection

The personal data of the participant(s) will be processed for the establishment, execution and handling of the contractual relationship with the organizer. This data may be passed on to third parties for the purpose of fulfilling the contract. 13. Photographs/film recordings

HSU/UniBw H is entitled to have photographs, film and video recordings made of the exhibition events, the exhibition structures and stands, the exhibited objects and the contributions in the conference program and to use them for its own advertising or media reports. By accepting these GTC-T, participants agree to appear on recordings and, if applicable, to be depicted in the publication of photographic, film or video material.

14. Final provisions

14.1 Should one or more clauses of these GTC-T be ineffective, this shall not result in the ineffectiveness of the entire contract. The invalid provision shall be replaced by the relevant statutory provision.

14.2 This contract shall be governed exclusively by German law.

14.3 The place of jurisdiction and place of performance shall be Hamburg, insofar as this can be effectively agreed between the contracting parties.

3. Purposes for which the personal data are to be processed:

The processing of personal data takes place for the purpose the realization of the (training) congress and the subsequent documentation and public relations work.

4. Legal basis for the processing

The data is collected on the basis of your consent (Art. 6 para. 1a, para. 7 GDPR). The processing of your data as part of the documentation of the event and public relations work is carried out on the basis of Art. 6 para. 1 e, para. 3 b GDPR in conjunction with § 3 BDSG.

5. Recipients or categories of recipients of the personal data:

For the purpose of access to the premises of Helmut Schmidt University/University of the Federal Armed Forces, the following personal data is transmitted to the barracks commander support staff: Surname, first name, company/institution

Your data will be forwarded to the Central Administration (Department II 1 - Budget) as part of invoice processing.

Photo, film or video material is published on our website, social media channels and in the press for publicity purposes.

6. Transfer of personal data to a third country or an international organization:

There is no transfer of personal data to a third country or an international organization and there are no plans to do so.

7. Storage period:

The data for registration for the congress will be deleted by 31.12.2025 at the latest.

Data in the context of accounting is subject to a retention period of 10 years due to tax and budgetary recording and retention obligations. Photographs and film recordings may be used indefinitely with your consent.

8. Rights of data subjects:

You have the following rights vis-à-vis the controller regarding your personal data Information in accordance with Art. 15 GDPR,

- Rectification in accordance with Art. 16 GDPR,
- Erasure in accordance with Art. 17 GDPR,
- Restriction of processing in accordance with Art. 18 GDPR,
- Data portability pursuant to Art. 20 GDPR
- Right to object in accordance with Art. 21 GDPR

You also have the right to lodge a complaint with the competent supervisory authority (Art. 77 GDPR). The supervisory authority is the Federal Commissioner for Data Protection and Freedom of Information (BfDI), Graurheindorfer Straße 153, 53117 Bonn, Germany.

9. Right to withdraw consent:

If the processing is carried out by submitting a corresponding (implied) declaration of consent, the consent can be revoked at any time with effect for the future. The legality of the data processing carried out on the basis of the consent until the revocation is not affected by the revocation.

10. Obligation to provide personal data and consequences of non-provision:

In the case of in-person participation, there is no obligation to remain within the camera's detection range, unless the type of event requires that the person present is also visually perceptible to persons participating online. In the case of online participation, this applies accordingly with regard to the activation of the camera. There is no obligation to tolerate or consent to a recording of your image and/or sound.

11. Existence of automated decision-making:

There is no automated decision-making.

Notes on sound/image/photo recordings during the event

Photographs and film recordings will be made during the Bundeswehr Education and Training Congress 2025. These may be published on our website, on social media channels and in the press in connection with reporting on the event in order to inform the public about this event. By voluntarily attending the event, you accept the accidental taking and publication of photographs and film recordings. If you do not wish to be photographed/filmed or do not agree to the publication of the photographs/films taken, please inform one of our employees during the event.

If individual persons are specifically/consciously identifiable (e.g. group photos, interviews,

etc.), their consent to the collection (photographing/filming) and processing and use is required. They will be informed separately and their consent obtained.

Data protection information-Virtual participation in the Bundeswehr Education and Training Congress

By participating in the Bundeswehr Education and Training Congress 2025, you consent to your personal data being processed as follows:

The conference system uses your Link and Learn user ID and password for authentication on the Bundeswehr learning management system.

Your name and your activity (MUTE/SPEAK) will be displayed to other participants. If you use a web cam, your picture and background will be displayed to other participants. If you share your desktop in the conference or allow access via remote control, the content of your desktop will be displayed to the other participants. Unauthorized access by third parties is excluded.

The event will be recorded and published for documentation and public relations purposes. The recording and storage of image and/or sound recordings is based on consent in accordance with Art. 6 para. 1 lit. a, Art. 7 GDPR (see below).

If you do not consent to the image recording, please leave the camera switched off. If you do not agree to the audio recording, please use the chat if necessary (log in without providing your participant name or with a pseudonym).

The program content will be recorded and published for documentation and public relations purposes. The recording and storage of image and/or sound recordings is based on consent in accordance with Art. 6 para. 1 lit. a, Art. 7 GDPR (see below).

If you do not agree to the image recording, place yourself outside the camera's field of view in the event room. Speeches will be moderated if you do not agree to the audio recording.

Pursuant to Section 22 sentence 1 of the Act on Copyright in Works of Fine Art and of Photography (KUG) I hereby declare my consent to that the within the framework of the (Education) Congress 2025 at the Helmut Schmidt University/University of the Federal Armed Forces Hamburg in the period (2.-4. At the same time, I consent to the further processing of my personal data for information and recruitment purposes in accordance with Article 6(1)(a) of the European General Data Protection Regulation (EU GDPR) and understand that the provision of my data is voluntary. There is no legal or contractual obligation to provide my data. I have the right to withdraw my consent in writing at any time with effect for the future; the legality of the processing up to the point of withdrawal remains unaffected by this. In addition to the right of withdrawal, I have the following data subject rights: access to my data (Article 15 EU GDPR), right to rectification (Article 16 EU GDPR), erasure (Article 17 EU GDPR), restriction of processing (Article 18 EU GDPR), objection to processing (Article 21 EU GDPR), right to individual examination (Article 22 EU GDPR). I also have the right to lodge a complaint with the Commissioner for Data Protection and Freedom of Information, Graurheindorfer Straße 153, 53117 Bonn, Germany (Article 77 EU GDPR). The storage of the data is necessary and intended for the period of use of the image recordings. The data will only be passed on to processors. No automated decision-making takes place.
